WHEREAS, the Entity is desirous that the Contractor execute GRAVELLING, CONCRETING OF GROUNDS AND IMPROVEMENT OF DRAINAGE OF OMSC LABANGAN (B-8661-16-22), hereinafter called "the Works" and the Entity has accepted the Bid for ONE MILLION ONE HUNDRED SEVENTY EIGHT THOUSAND SEVEN HUNDRED TWENTY TWO PESOS AND 71/100 (P1,178,722.71) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (i) Eligibility requirements, documents and/or statements
 - (j) Performance Security
 - (k) Notice of Award of Contract and the Bidder's conforme thereto
 - (l) Construction Safety and Health Program approved by the Department of Labor and Employment specific to the project
 - (m) Construction Schedule and S-curve
 - (n) Manpower Utilization Schedule
 - (o) Narrative Description of Construction Method
 - (p) Equipment Utilization Schedule
 - (q) PERT/CPM specific to the project
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




