Description

- The OCCIDENTAL MINDORO STATE COLLEGE (OMSC), through the Special Trust Fund intends to apply the sum of Thirteen Million Four Hundred Forty Nine Thousand Pesos Only (P13,449,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Two-Storey Laboratory Building at OMSC Labangan (B-8661-16-27). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The OCCIDENTAL MINDORO STATE COLLEGE (OMSC) now invites bids for the following project identified under Project No. B-8661-16-27, for the construction of two-storey laboratory building at OMSC Labangan Campus, San Jose Occidental Mindoro with an approximate total area of 1,092.50 sq. meters. Completion of the work is required three hundred sixty (360) calendar days after receipt of Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

9. Prospective bidders should possess a valid PCAB license of Medium A, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment available for prosecution of the contract.
