


CONTRACT AGREEMENT

THIS AGREEMENT, made this 14 day of AUG 14 2017 between OCCIDENTAL MINDORO STATE COLLEGE, Rizal St., San Jose, Occidental Mindoro, hereinafter called the "Entity" and FIRMABUILT CONSTRUCTION, Marsan Village, San Roque II, San Jose, Occidental Mindoro, represented by Ms. Marilyn P. Novilla, Proprietor/Authorized Managing Officer, hereinafter called the "Contractor".

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF LABORATORY BUILDING AT OMSC SABLAYAN (B-8661-17-11), hereinafter called "the Works" and the Entity has accepted the Bid for FOURTEEN MILLION NINE HUNDRED NINETY SIX THOUSAND FOUR HUNDRED FORTY SEVEN PESOS AND 40/100 (P14,996,447.40) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract
 - (b) Drawings/Plans

 - (d) Invitation to Bid
 - (e) Instructions to Bidders

 - (g) Addenda and/or Supplemental/Bid Bulletins, if any
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements
 - (j) Performance Security
 - (k) Notice of Award of Contract and the Bidder's conforme thereto
 - (l) Construction Safety and Health Program approved by the Department of Labor and Employment specific to the project
 - (m) Construction Schedule and S-curve
 - (n) Manpower Utilization Schedule
 - (o) Narrative Description of Construction Method
 - (p) Equipment Utilization Schedule
 - (q) PERT/CPM specific to the project
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
