- The decline in the collection of tuition fees in the 3rd & 4th quarter brought a small variance from the targeted collection of tuition fees due to the late receipt of financial scholarship package from the Provincial Government of Occidental Mindoro (PGO Scholars) for the 1st semester of AY 2015-2016 and the Commission on Higher Education for Iskolar ng Bayan Program for the 1st & 2nd semester of AY 2015-2016 aggregating to more than six million pesos only. In addition, promises made by students' parents were accommodated in the understanding that the accounts shall be paid by the end of the semester.
