

CONTRACT AGREEMENT

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION OF ONE-STOREY STAFF HOUSE AT OMSC MAMBURAO (B-8661-14-20), hereinafter called "the Works" and the Entity has accepted the Bid for FOUR HUNDRED EIGHTY-NINE THOUSAND SIX HUNDRED FORTY-SIX PESOS AND 04/100 (P489,646.04) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
