The OCCIDENTAL MINDORO STATE COLLEGE (OMSC), through the General Fund/Special Trust Fund intends to apply the sum of Two Million One Hundred Twenty-Six Thousand Pesos and 0/100 (Php2,126,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply and Delivery of IT Equipment and Peripherals (B-8661-15-12). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC) now invites bids for the Supply and Delivery of IT Equipment and Peripherals.

Delivery of the Goods is required thirty (30) calendar days after receipt of Notice to Proceed. Bidders must have an experience of having completed, within a period of five (5) years from date of submission and receipt of bids, at least one (1) contract that is similar to the project to be bid and whose value must be at least 50% of the ABC.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty
