#### Description

1. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC), through the Special Trust Fund intends to apply the sum of One Million Seven Hundred Ninety-nine Thousand Nine Hundred Fifty-nine Pesos and 25/100 (P1,799,959.25) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of One-Storey Student Services Center at OMSC Labangan (B-8661-15-19). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC) now invites bids for the following project identified under Project No. B-8661-15-19, for the construction of one-storey student services center at OMSC Labangan Campus, San Jose, Occ. Mindoro with an approximate total area of 190 sq. meters. Completion of the Works is required one hundred twenty (120) calendar days after receipt of Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the OCCIDENTAL MINDORO STATE COLLEGE and inspect the Bidding Documents at the address given below during office hours, Mondays to Fridays (8:00-12:00/1:00-5:00)

5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below from October 1, 2015 and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos Only (P5,000.00)
6. The OCCIDENTAL MINDORO STATE COLLEGE will hold a Pre-bid Conference on October 9, 2015, 4:00 PM, at the BAC Office, 2F PTM Hall, OMSC Main Campus, San Jose, Occidental Mindoro which shall be open only to all interested parties who have purchased the Bidding Documents. Interested bidders must attend the pre-bid conference.
7. Bids must be delivered to the address below on or before, October 21, 2015, 3:30 pm at the BAC Office, 2F PTM Hall, OMSC Main Campus, San Jose, Occidental Mindoro. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bid opening shall be on October 21, 2015, 4:00 PM at BAC Office, 2F PTM Hall, OMSC Main Campus, San Jose, Occidental Mindoro. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment available for prosecution of the contract.
10. The OCCIDENTAL MINDORO STATE COLLEGE reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. The OMSC further assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.
