#### Description

1. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC), through the General Fund intends to apply the sum of Five Million Pesos Only (Php5,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Two-Storey/8-Classroom Building (Phase II) at OMSC Mamburao (B-8661-17-10). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC) now invites bids for the following project identified under Project Reference No. B-8661-17-10 for the Construction of Two-Storey/ 8-Classroom Building (Phase II) at OMSC Mamburao with an approximate area of 406 sq.m. consisting of four-classroom/laboratory room with sliding glass door in between classrooms. Completion of the works is required 210 calendar days after receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from OCCIDENTAL MINDORO STATE COLLEGE (OMSC) and inspect the Bidding Documents at the address given below from Mondays-Fridays (8:00 A.M. – 12 P.M. / 1:00 P.M. – 5:00 P.M.).
5. A complete set of Bidding Documents may be acquired by interested bidders on May 13, 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the CRRP in the amount of ₱ 1,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC) will hold a Pre-Bid Conference on May 22, 2017, 4:00 PM at BAC Office, 2F PTM Hall, OMSC Main Campus, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Bidders who opted not to attend the Pre-Bid Conference shall be required to purchase Minutes of the Pre-Bid Conference upon purchase of bid documents in the amount of Five Hundred Pesos Only (Php 500.00) per set.

7. Bids must be duly received by the BAC Secretariat at the address below on or before June 6, 2017, 1:30 PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on June 6, 2017, 2:00 PM at BAC Office, 2F PTM Hall, OMSC Main Campus, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Notice of Postponement and Bid Bulletin shall be issued should the scheduled date of Pre-Bid and Opening of Bids fall under special holidays.

8. Prospective bidders should possess a valid PCAB license of Small B, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment available for prosecution of the contract.

9. The OCCIDENTAL MINDORO STATE COLLEGE (OMSC) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
